# ACCA FAQs

## 1. How many years will it take to complete the ACCA program?

It is advisable to complete it along with your B.com/MBA. However, you can complete your ACCA even after your B.Com/MBA. It is just the exemptions expiry that you need to be cautious about.

## 2. Do I have to study B.com/MBA and ACCA separately?

The answer is 'No' for the major part of your ACCA. The 9 exempted subjects are included in your regular B.Com/MBA syllabus. There are 4 non-exempted papers which are the Professional Level papers. 2 out of these papers, namely SBL and SBR are mandatory for ACCA and are included in your syllabus. The remaining 2 are called optional papers and you have to choose these 2 papers out of 4 options (AAA, AFM, ATX, APM). We cross that bridge when we get there and anyone interested in these optional papers can get in touch with the University for the way forward.

## 3. Will my 4 non-exempted papers exams be conducted by the university?

No, since these are non-exempted papers, you will have to appear for the exams conducted by the ACCA Body (UK) directly. You will be assisted with the procedure on how to book your exams.

#### **4. If I fail to qualify all 4 non-exempted papers by Sem 6 (B.com)/Sem 4 (MBA), will I get the degree?**

Yes, you will get the B.com/MBA degree from the University, and once you qualify all 4 non-exempted papers, you will get certification from ACCA as well and you will then be called an ACCA Affiliate.

#### **5. If I do not wish to continue with the pending non-exempted ACCA exams, will I get my degree?**

Yes, you will still get your B.com/MBA degree from the University even if you do not take the ACCA Body examinations for the non-exempted papers.

#### **6. Does the course have any value after graduation?**

Yes, the course has value all over the world as it's recognized in more than 180+ countries. You can make your career in various fields such as Audit, taxation, accounting, etc.

#### **7. Do I have to prepare for the non-exempted ACCA Papers separately?**

Mandatory papers SBL and SBR will be covered in your B.com/MBA journey. 2 optional papers are to be prepared separately, and you can get in touch with the University when you are done with SBL and SBR.

## **8. Can I start working in my last year?**

Yes, you can start working even if you are left with a few papers. You are still considered a Partially qualified ACCA and get good roles with good CTCs.

## **9. Will I be getting any Scholarships on ACCA fees?**

There are no scholarships as such. However, if you have registered or are going to register with ACCA body through Amity, you get your exemption fees waived off for the 9 exempted papers. For those who are not aware, exemption fees are the examination fees for your exempted papers.

## **10. I am from a science background. Am I still eligible for the program?**

Yes, ACCA can be done by anyone regardless of their educational background.

## **11. Are my 4 non-exempted ACCA exam fees included in the program fees?**

The program fee does not include your exam fees. The exam fees are to be paid directly to the ACCA body when you book your exam.

## **12. Do I have to pay examination fees of all 4 non-exempted papers in one go to the ACCA Body?**

No, you do not have to pay examination fees of all 4 non-exempted papers in one go. You pay the examination fee for only that paper(s) which you wish to book or appear for in the quarter.

## **13. When is the subscription fee payable?**

The subscription fee for the first calendar year is waived off and is then payable annually from the next calendar year onwards. This fee is paid directly to the ACCA Body and is not included in the program fees.

## **14. In which case is exemption fee payable?**

As per the ACCA Body policy, if you have not registered with ACCA via Amity University, you will still get exemptions, but you will have to pay exemption fees.

## **15. How can I become ACCA Member?**

To become an ACCA member, the students need to –

- Complete their 13 papers (Affiliation)
- Complete PER (Practical Experience Requirement) of 36 months in the field of F&A
- Complete EPSM Module
- Apply for Membership with ACCA via my ACCA account.

## 16. What is the procedure for converting conditional exemptions into permanent exemption.

When a student gets registered with ACCA for their integrated program with the University, they are granted 9 Conditional Exemptions.

To convert these Conditional Exemptions into Permanent Exemptions, students must submit their Passing Certificate and Marksheets to the ACCA Body. As per the ACCA Body policy, the students get 1 year to submit these documents calculated from the time of normal graduation (which is 2 years from the date of program commencement for MBA and 3 years from the date of program commencement for B.com). In other words, these documents must be submitted within 3 years (for MBA) and 4 years ( for B.com) from the commencement of the respective programs. Failure to do so results in lapsing of those exemptions.

For e.g, if a student has enrolled in the B.com July'23 intake, the normal graduation will be in 2026 as B.com is a 3-year program (the normal program). As per the ACCA Body policy, such a student will get time until 2027 to submit all relevant documents mentioned above to convert the conditional exemptions into permanent exemptions.

Similarly, if a student has enrolled in the MBA July'23 intake, the normal graduation will be in 2025 as it is a 2-year program (the normal program). As per the ACCA Body policy, such a student will get time till 2026 to submit all relevant documents mentioned above to convert the conditional exemptions into permanent exemptions.




